



## AMPed Up! Conference Terms and Conditions of Registration and Attendance

By registering and paying for a ticket to attend the AMPed Up! 2025 Conference, delegates agree to abide by the Terms and Conditions of sale.

### Payment Options and Terms

All ticket prices are in Australian dollars (AUD) and are inclusive of GST. Where possible delegates are encouraged to pay via credit card using the TryBooking ticketing platform.

Online registrations and payment via credit card may incur a booking fee.

If you choose to pay via EFT or cheque, please contact Limbs 4 Life directly. We will raise a Tax Invoice for the cost of your registration. Full payment of the invoice must be received within 14 days of issue.

If you register during the 'Early Bird' booking period, you must ensure that payment is made prior to the close of 'Early Bird' rates.

### Event Cancellation or Postponement

Should circumstances beyond the control of Limbs 4 Life (the organiser), or the venue (namely Adelaide Convention Centre ACC) arise, Limbs 4 Life will endeavour to reschedule the event.

All tickets purchased will be transferred and valid for the re-scheduled conference event. If the event is rescheduled and you are no longer able to attend, a refund will be issued.

Limbs 4 Life accepts no liability if an event is cancelled or postponed for reasons beyond their control.

### Ticket Cancellations and Refunds

Should your circumstances change, and you are unable to attend AMPed Up! 2025, written notification to Limbs 4 Life must be received prior to 1 March 2025. A cancellation fee of \$10 per ticket will apply. Failure to receive a request in writing will result in full registration remaining payable.

Any credit card surcharges or merchant fees payable at the time of purchase are non-refundable. Refunds will only be processed to the credit card or financial institution from which funds were received. Please allow five business days for funds to be returned.

If you have not received an acknowledgement of your cancellation request within two business days, please contact Limbs 4 Life.
